## Release 2.10 (July 2018)

---

### New features

Issue ID	Description
VMS-1357	Stream video from mobile device to Symphony You can add the camera on an Android device to Symphony and stream video from the device to Symphony.

### Fixes

Issue ID	Description
VMS-1462	You can enable and disable rules as expected on Android devices.
VMS-1618	Video shows the correct time when you play it backwards on an Android device.
VMS-1687	The Symphony Mobile Application shows the correct state for the input of a DIO device when you change the output.

## Release 2.7.8 (August 2017)

---

The Android Mobile Application 2.7.8 works with Mobile Bridge 2.7.4 and later with supported Symphony 7.x releases, or Mobile Bridge 2.2.3 with supported Symphony 6.x releases.

### Fixes

Issue ID	Description
VMS-1497	The Android Mobile Application can display video that has an audio stream.

## Release 2.7.7 (November 2016)

---

The Android Mobile Application 2.7.7 works with Mobile Bridge 2.7.4 and later with supported Symphony 7.x releases, or Mobile Bridge 2.2.3 with supported Symphony 6.x releases.

### Improvements

Issue ID	Description
VMS-1201	The Android Mobile Application includes build numbers in the Settings > About section.

### Fixes

Issue ID	Description
VMS-1197	Swiping through cameras does not cause flickering.

## Release 2.7.6 (October 2016)

---

The Android Mobile Application 2.7.6 works with Mobile Bridge 2.7.4 and later with supported Symphony 7.x releases, or Mobile Bridge 2.2.3 with supported Symphony 6.x releases.

### Fixes

Issue ID	Description
VMS-1246	Live video starts in the Android Mobile Application if Symphony services are restarted using the <code>killall -r</code> command. This requires Mobile Bridge 2.7.4.1 or later.
VMS-1247	The Android Mobile Application does not display duplicate entries in the Connection list.
VMS-1249	The Android Mobile Application does not stop responding if port 8488 is not open.

## Release 2.7.5 (October 2016)

---

The Android Mobile Application 2.7.5 works with Mobile Bridge 2.7.4 and later, or Mobile Bridge 2.2.3 with supported Symphony 6.x releases.

### Fixes

Issue ID	Description
VMS-1243	The Android Mobile Application displays video when it is connected to a Wi-Fi network from a LAN different from the LAN that the Mobile Bridge is connected to.

## Release 2.7.4 (October 2016)

---

The Android Mobile Application 2.7.4 works with Mobile Bridge 2.7.4 and later, or Mobile Bridge 2.2.3 with supported Symphony 6.x releases.

 **Important:** To configure video streaming on mobile devices, see [KB 10448](#).

### Fixes

Issue ID	Description
VMS-1229	The Android Mobile Application uses the internal and external IP addresses of the Symphony server for RTSP correctly.



## Release 2.7.1 (September 2016)

---

The Android Mobile Application 2.7.1 works with Mobile Bridge 2.7.1 and Mobile Bridge 2.2.3.

### Fixes

Issue ID	Description
VMS-1219	The Android Mobile Application can display video when using a WAN IP.
VMS-1222	The Android Mobile Application can stream video from all Symphony servers in a multi-server farm using a WAN IP.

## Release 2.7 (September 2016)

---

Symphony Mobile Bridge 2.7 works with Symphony 7.0. Mobile Bridge 2.7 does not work with Symphony 6.x or earlier.

The Android Mobile Application 2.7 works with Mobile Bridge 2.7 and Mobile Bridge 2.2.

### Improvements

Issue ID	Description
VMS-760	JPG and video performance has improved.

### Fixes

Issue ID	Description
VMS-1076	The Android Mobile Application displays H.264 video compression standard video reliably.
VMS-1081	The Android Mobile Application connects to Mobile Bridge reliably.
VMS-1121	The Android Mobile Application streams live video consistently.
